- II. Approval of minutes from last meeting** - 5 min *August minutes will be sent out via email and approved before the next meeting. September Draft minutes will also be sent to council members and approved at the October meeting.
- III. Counselor Update** – 5 min Seventh Grade PCCRs are underway! College and Career awareness lessons will be taught by school counselors through the first term. This will facilitate an earlier information night for incoming 7th graders than in the past (to be held in January or February) and earlier course request availability for those going into 8th and 9th for the 2023-24 school year.

IV. Principal Update – 10 min

- a) Parent Night -there were 3 sessions held and the goal is to hold more every couple of months to help families navigate the Summit program.
- b) PT Conferences - Parent teacher conferences will be held once per term in an effort to monitor student progress and have time for interventions when desired/needed. These will be held in person with teachers in the gym. Upcoming PT Conferences September 28th from 3:30-7pm.
- c) Dress Code Input- Concerns about consistency in enforcing dress code for our student body of almost 1,000 and the impact on students who get singled out for dress code violations. Would like input on current dress code policy and consideration of possible change to dress code. Topic will be explored further and included as a future agenda item for discussion. Michelle Milburn and Rachael Dixon volunteered to look into further solutions.
- d) Oct 5th there will be a community council training at Farmington High School with Superintendent Linford from 4-5pm. There will also be a district training Oct 19th, via zoom for Community Councils. State Training will then be provided (attendees can choose either November 9th or 14th at 12pm or 7 pm).

V. New business

- a) Timeline, Roles & Procedures, Training 10 min (provided by Gin Allred)
Community Council is tasked with: Trustland Fund expenditures and reports, School Safety Plan, Digital Citizenship, and school specific issues. Concerns about safety with crosswalk from the rail trail and traffic concerns, specifically at the intersection of Western Drive and Sunset Drive were brought up. Topic needs further discussion. Michelle Thomson brought up the question of SEL goals also being part of our tasks. That will be reviewed further as well.
- b) Librarian and Council Member Tina Johnson shared the need for a Community Council appointed member for the Library Committee. McKenzie Evans volunteered and was approved. The Library Committee will assist in the acquisition of library materials.
