V. New Business

- a) Kim Morrison (Summit)– (30 min) Kim expressed concerns over the Summit Learning Platform. She shared documentation questioning the effectiveness of Summit, statements from Utah Medical Providers with regard to Summit's negative impact on some of their patients, and feedback from surveys she has been able to collect from students, parents, and teachers who have used Summit. She shared three requests with the council: to invite all parents to give feedback on the Summit Learning platform through a survey, to consider making the Summit Learning Platform an opt-in situation, and that no funds be approved for Summit or PCBL (Personal Competency-Based Learning) until feedback has been obtained from the community. A proposal to have a sub-committee formed to look at these requests was made and 9 votes from Community Council were in favor of doing this.

Note: Principal Thompson shared that plans to get student input about their first semester experience in Summit are already in place.
